## Op-Ed: Putting Automation on the Mayor's Agenda

A fully automated city may still be more science fiction than fact, but era-defining changes are already here. The city must prepare for the wave of automation or be left in its wake.

Automation is threading through every level of New York City's economy, from warehouses and food courts to trading floors and operating rooms. But too many New Yorkers are ill-equipped.

In this *Crain's New York Business* op-ed, Center for an Urban Future's policy director and Fisher fellow Matt A.V. Chaban and Fisher Brothers partner and co-chair of the New York City Regional Economic Development Council Winston C. Fisher argue that Mayor Bill de Blasio and the City Council no longer have the luxury of time. Policymakers will have to take action in the next four years to help prepare New Yorkers with the skills they need to thrive in an automated future.
